The export promotion initiative of the GACIC is supporting Egyptian exporters. Within that framework, the GACIC provides an opportunity to discuss various issues with representatives of the government as well as other Egyptian exporters.

GACIC's Export Committee meeting took place on October 14, 2003 at Sekem Farm. The meeting, which was moderated by the managing director of Sekem, mainly discussed the publication of The Global Competitiveness Report 2001-2002.

The Global Competitiveness Report 2001-2002 focused on two distinct but complementary approaches to the competitiveness index and the current competitiveness index.

The report emphasized an important theme confronting many nations. Countries face different challenges as they move from resource based to knowledge-based economies. The principle factors that contribute to global competitiveness are investment driven and innovation driven economy. The committee members further held an open-ended discussion on Egypt's overall competitiveness ranking was looked at and analyzed.

The discussion resulted in agreement that Egypt's RND, Innovation and ICT has to be enhanced. Although, Egypt's Telecommunication, is ranked No. 4 worldwide in the ICT Sub index, yet promoting ICT and the overall business environment has to be developed.

On another note, the committee members highlighted the importance of expanding exports, the concept of improving export services and suggested tax exemption for the amount of salaries paid to exporters.
