The Confederation of Egyptian-European Business Associations

The Confederation of Egyptian- European Business Associations was founded in May 2004. This confederation consist of agreements was signed between the Egyptian- Italian Chamber, the Egyptian- German Chamber, the Egyptian- British Chamber, and the Egyptian- French Chamber.

This has been considered a major leap in Egyptian- European relations. The new confederation started with over 3000 members that are the members of founding associations that have been working in Egypt for over half a century. Their knowledge, technical, and administrative qualities could well boost joint cooperation between major business associations and aid authorities throughout Europe.

This formation is considered the best among those submitted for discussion in over six months. These discussions were held between joint business organizations along with the head of the European Union, European Delegations, and ambassadors of the European Union. This formation ensures that cooperation will be improved with respect to the complete independence of existing organizations.

This important step came due to an understanding of the severe need for a strong non-governmental organization on both the Egyptian and European sides. Eespecially in the presence of several well-established business organizations and bilateral chambers of commerce. At times, it have been witnessed the lack of a vehicle for coordination among them to build cooperation with the organizations and authorities of the European Union

In addition to a lack of specialized business organizations to activate the relationship between Egypt and the European Union members who do not have joint chambers, The Confederation aims at creating a common high level Egyptian-European dialogue.

It aims to enhance cooperation between Egyptian business organizations to unify the European cooperation front, in addition to increasing interest from European partnership agreements and preparing for Euro med Free Trade Zone in 2010. The Confederation also plans to accelerate the process of modernization, the transfer of advanced technology and management methods, and encouraging the investment and promotion of Egyptian exports to the Euro med market.

The Confederation will also play the role of joint bilateral chambers of European Union members which do not have their own chambers, by presenting several services through relevant organizations along side implementing numerous European programs, on which many are decentralized programs.

The activities of the Confederation include supporting the joint Egyptian-European dialogue and inviting opinions on current issues through technical reports, workshops, seminars and panel discussions in addition to the declared opinions by European delegations and missions of European Union members.

The Confederation will become the primary source of data for Egypt and Europe besides being the coordinator of numerous joint Egyptian- European programs. It will support and establish new business associations for European Union members who currently do not have bilateral associations.

The membership of the Confederation includes the heads of the four founding organizations, one representative of each European Union member, the chairman of the joint business organization, if any, or the president of any company operating in Egypt selected from among three candidates nominated by their embassy. There will be no direct company memberships since this will be left up to the bilateral business organizations.

Moreover, no membership fees will be accepted, since the founding organizations will finance all activities in addition to financing made from grants and joint projects which the member organizations will implement. The German Chamber will host the General Secretariat of the Confederation.

The Confederation will consist of an Advisory Council of the representatives of the 25 member states, headed by the representative of the state led by the European Union which will change every six months starting with Holland first.

There will be an Executive Board formed of the representatives of the four founding organizations and three members from the Advisory Council which represent the fifteen original member states and representatives of the ten new

states, to be changed every six months consistent with the same list as the head of the European Union.

The Executive Board will be chaired for one year in turn by a representative of one of the founding states starting with the U.K., as it was the first head of the European Union. The General Secretariat will be managed by a Secretary General selected by the Executive Board.
