Tertiary National Seminar on Employment Policy in Egypt

Cairo – October 12 & 13, 2004

In October 2002, an ILO mission visited Cairo, with the aim of comprehensively reviewing the employment policy in Egypt. The visit was organized in close coordination with Minister of Manpower & Immigration Mr. Ahmed al-Amawi and his ministry.

On this occasion, all ministers concerned with the overall economy policies and sector policies, together with senior officials and academicians, met with the mission, in order to exchange viewpoints on the employment policy.

At the end of the visit, the mission came up with a memo designing the broad lines of the approach to be adopted in the process of reviewing the employment policy.

At the outset of 2003, the ILO embarked on implementing this review, where it enjoyed the kind assistance of prominent Egyptian academicians. Several studies were launched, in which aspects of the employment policy were tackled at the overall & sector level, as well as the labour market level.

Research topics covered the formulation of an incentive structure for encouraging higher employment levels and better productivity; encouragement of exports to raise employment levels; repercussions of liberating trade on employment in small and medium institutions; work requisites in an unorganized economy; appropriate organizational framework for creating job opportunities in small and medium institutions; assessment of two components within the youth employment programme; in addition to preparing the first book in Arabic on labour market active policies.

The Tertiary National Seminar on Employment Policy in Egypt will convene on October 12 & 13, 2004, in order to discuss the outcomes of researches carried out by Egyptian academicians, under the auspices of the ILO.

The Tertiary National Seminar includes government representatives, social associates and academicians, in addition to a number of public figures concerned.

The main objective of the seminar is to furnish policy-makers with useful elements in formulating the employment policy, capable of creating productive job opportunities and raising the level of productivity, while curbing poverty.

Also, discussions and conclusions of the seminar might hopefully contribute to the formulation of a national work plan for youth employment, as expected from Egypt to be submitted to the UN, together with other Member States of the ILO.

It is worth mentioning that Egypt is one of the eight leading countries within the youth employment network sponsored by the UN, ILO & World Bank. Furthermore, the seminar is expected to define a number of new domains that call for research on appropriate procedures for the employment policy. During the first phase that lasted for the past eighteen months, focus was primarily made on the aspect of employment demands, where the next phase could tackle the aspect of supply.

Another vital issue that deserves a great deal of concern is employment in the agricultural field and in rural areas.
